Construction Site Security



PROBLEM

A construction site has been hit by vandals several times over the last month. To stop the trouble, the owner of the business installed security cameras and hired a night security guard. Everything was quiet for a few nights, then the site was hit again. While the security guard was patrolling on the other side of the lot, three men cut the chain link fence. By the time the guard arrived, the truck was driving away with a large tool chest, several rolls of copper tubing and a generator in the back. They had also cut the hydraulic lines on an excavator. The loss and damages ran to more than \$15,000 and the construction crew lost days of work. The security footage recorded the incident, but the police had little to work with from the video when it came to catching the thieves and recovering the stolen property.

Criminal activity like this is all too common in the US. In 2014, there were more than 8 million reported incidents of theft, vandalism and other property crimes. EXISTING SECURITY MEASURES

There are many existing choices to choose from to reduce the incidence of trespassing and other criminal activity. Unfortunately, the three most popular choices each have problems:

Alarm Systems

Alarm systems detect intrusions and alert property owners with a siren or a bell. Some systems can automatically call the police when the alarm is tripped. One major issue with alarm systems are false alarms. This is one reason that law enforcement is often slow to respond to alarms. If the police do respond to a false alarm on your property, you could be liable for the cost of their response.

Video Surveillance

Video surveillance systems are very good at recording crimes, but they do nothing to prevent them. Even with video footage, the odds of arresting the criminals are quite low.

On-Site Security

On-Site security provided by a security guard is quite effective, but also very expensive. However, even with an on-site security guard, criminal activity may still occur. A person can only be in one place at a time; he or she may not be where the criminals are. On-Site security may be posed a potential threat by intruders in the event of a theft or break in.
